#### 1. OPENING CAC COMMENTS

#### **CAC Business**

- The May and September Meeting minutes have been approved by FHR and will be sent to you this week. Finalize at the November meeting.
- CAC Administrative Process Updates
  - New administrator starting. Mediation Center will review and update procedures.
  - Maintain independence while also streamlining, using newer technologies
  - Move to Google Voice
  - Use Google Calendar Invites
- Community Outreach Committee Updates
  - Flint Hills Tours—As the interest increases among the FHR provides tours to the public. When15-20 people have requested a tour, a tour is scheduled. William Klein volunteered to attend the public tours to hand out information on the CAC.
  - A member suggested the possibility of a Flint Hills Refinery documentary through TPT. The cost would be around \$15K

for a 30-minute video to be shown 6 times. Would need to keep in mind for annual budget planning.

- 2023 will be Flint Hills 25<sup>th</sup> Anniversary of the CAC.
- A member suggested having a booth of the CAC at the Dakota County Fair, Leprechaun Days and other Public celebrations to spread the word about the CAC.

# 2. PINE BEND BLUFF RESTORATION PRESENTATION-Karen Schick, Friends of the Mississippi River presented on their bluff restoration activities and progress.

- Pine Bend Bluffs cover 1300 acres
- Flint Hills Resources are over ½ of the 1300 acres
- Pine Bend Bluffs-have diverse landscape, habitat for a diverse wildlife
- Goals for restoration are to sustain and improve the oak forest plant communities to better allow native plants to survive, and to restore prairies to their historic condition.

#### 3. FHR Monthly Updates

### FHR Process Safety and Environmental Update

Several incidents with no injury had the potential for bad outcomes. We continue to focus on process safety. FHR received the MN Star recertification for our knowledge and level of process safety.

#### FHR Personal Safety Update: Susan Titel

There have been 22 injuries since May—13 FHR related, and 9 Contractor related. Our focus on process and prevention has increased reporting of incidents. Mostly nagging pains-sprains/strains. Others included a pinched finger, vehicle hitting a power pole outside the fence and improper use of tools.

  - o Comment: The fine seemed too low.

- Bjorn Olson presented to the Council the FHR Employee Training Program and how ongoing the process is for the employee for up to a 5-year period.
- Bjorn then took the CAC into an adjoining room to demonstrate a virtual training exercise for locating a leak and what to do/how to handle once spotted.
